



Irish Tillage and Land Use Society -- Membership

Membership of the Irish Tillage and Land Use Society (ITLUS) is available to anyone within the agricultural sector, subject to the agreement of the Council of ITLUS. The society aims to provide education, experience, social and travel opportunities for its members. Each year the society organises a workshop or seminar in springtime; it is a co-organiser of the Agricultural Research Forum; a Summer Field Meeting to somewhere on the Island of Ireland; and a topical conference in early December. And every second year the Society organises a Foreign Study Tour to experience agricultural production somewhere else in the world.

The society events are also generally open to all but non-members may be asked to pay extra to some events. Membership is easy and can be arranged by filling out this application form. The society would prefer that members sign up for payment by direct debit but will accommodate most types of payment. Cash payments are also accepted but on a multiannual basis for a period of five years. This is because of the high administrative cost of attempting to secure annual payments. Corporate membership is also available to companies and other organisations but this membership does not afford voting rights.

The society is run by a council which comprises of the offices of President, President Elect, Secretary/Treasurer and Registrar in combination with other Council Members. The Council is elected annually at the AGM during the winter conference.

Application for membership involves the completion of the attached form(s). All applicants must complete Section A and those opting to pay by direct debit must fill out Section B. Membership cost is currently €30 per annum.

The new bank requirements for SEPA (Single Euro Payments Area) require that Section B be completed and held by ITLUS for new members.
